City of Boyden Minutes of Monthly Council Meeting May 8, 2023

Mayor Laryl Koerselman called the meeting to order at 5:30 pm.

Council members present were Stacie Damstra, Robing Jungers, and Bob Koerselman. Nathan Alexander arrived at 5:35pm. Austin Loges arrived at 5:45pm.

Other's present was city employees Tami Kamies.

Mayor Koerselman opened the public hearing for the fiscal year 2023 budget amendment at 5:32 pm. B. Koerselman introduced Resolution 2023-13 authorizing to adopt the budget amendment for the fiscal year ending June 30, 2023. There were no written or oral comments. Jungers seconded the motion to adopt. Roll call vote 3-0. Resolution passed. Mayor Koerselman closed the public hearing at 5:33 pm.

Maintenance Report –

Council discussed collecting bids on redoing the Demco Center. We will separate bids on doing the exterior of the building as well as doing the interior of the building. Once bids are received the city will apply for a grant.

A discussion was also had regarding the trees in the park that will need to come down due to the Emerald Ash Borer. B. Koerselman made a motion that the city will spend \$6,000 for tree removal this summer/fall around the playground. Loges support. Motion carried 5-0.

Council discussed the park cleaning position and the counter offer that Marci had presented to council regarding the amount paid for the position. B. Koerselman made a motion that city will decline the offer but will still offer Marci first chance at cleaning the park for \$2,600 from May 15- September 15. If she does not want the position the city will post the position, since there have been other interested parties for the position. Loges support. Motion carried 5-0.

B. Koerselman left the meeting at 6:10 pm.

Consent Agenda -Jungers made a motion for approval of the bills in the amount of \$211,361.73, the April financials, and the April 10 minutes, the FY24 Sheriff's contract, and the building permits for Jon Draayer and Bruce Schafer. Alexander support. Motion carried 4-0.

Loges introduced the Resolution approving the contract and bond for the 2023 street and utility improvements and moved its adoption. Alexander seconded the motion to adopt. Roll call vote: 4-0. Resolution was adopted.

A discussion was had regarding property owned by the city and whether the city would sell the property for development. There will be further discussion with the interested party and the possibility for development.

Alexander made a motion to approve the file retention policy which will regulate the retention of city records. Damstra support. Motion was carried 4-0.

With no further business Alexander made a motion to adjourn the meeting. Loges support. Motion carried 4-0. Meeting was adjourned at 6:50 p.m.
