Mayor and Council Comments - none

Colleen spoke in regards to her experiences in cleaning the Demco Center. There have been some parties that have taken place that have left the facility in a state of being abused beyond what should be allowed in the facility. Council has decided that until they can review the policies and rules, they will not allow any rentals in the facility except for corporate functions or funerals. Any rental agreements that have been made previous to this decision will be allowed to be held. They will continue to review and discuss at the next council meetings.

Loges seconded the motion to adopt. Roll call vote 4-0. Resolution was adopted.

Alexander made a motion to approve Resolution 2023-17 approving the 2022-2023 lowa DOT Street Financial Report. Damstra seconded the motion. Roll call vote 4-0. Resolution was adopted.

Council reviewed the Fiscal Year 2022-2023 Annual Urban Renewal Report presented to them. Jungers made a motion to approve the report. Loges seconded the motion to approve. Roll call vote 4-0. Motion carried.

Councilman Alexander introduced Resolution 2023-18 proposing to dispose of municipally owned real estate and setting the time and place of the public hearing and moved to adopt and set the hearing for November 13 at 5:30pm. Loges seconded the motion to adopt. Roll call vote 4-0. Resolution was adopted.

Council reviewed the construction contract documents for the Prairie Street Sewer Lining project. Loges made a motion to approve. Damstra support. Motion carried 4-0.

With no further business Alexander made a motion to adjourn the meeting. Damstra support. Motion carried 4-0. Meeting was adjourned at 6:20 p.m.
