February 14, 2022

Mayor Laryl Koerselman called the meeting to order at 5:30 p.m.

Council members present were Robin Jungers, Stacie Damstra, Austin Loges, and Bob Koerselman. Nathan Alexander called in to the meeting at 5:30.

Other's present were city employees Jerry Lode, and Tami Kamies.

Mayor Koerselman opened the public hearing for the max levy rate at 5:30 pm. There were no written or oral comments. Resolution 2022-04 approving the total maximum levy for affected property tax levies for FY2023 to be \$264,690. Roll call vote: 5-0. Resolution passed. Mayor Koerselman closed the public hearing at 5:32.

Nathan Alexander left the meeting at 5:33.

Brent Steven is requesting that the training for the Ambulance be done through an online training system. This would allow for easier tracking of classes and credit hours for each individual. Jungers made a motion to approve the online training. B. Koerselman support. Motion carried 4-0.

Maintenance Report – Jerry discussed having a light put up at the lift station. The previous light was damaged during a previous wind storm. A discussion was had regarding redoing the landscaping by the city/library building as well as the Demco Center. We will get prices on different edging options. Council had a discussion about replacing trees in the park. Bob will talk to Art Van Bruggen to see what trees he has available and what he thinks would be a good type of tree to put in the park. The city will also look at starting our own small tree farm in anticipation for trees to replace in the park in the years to come.

Consent Agenda -Jungers made a motion for approval of the bills in the amount of \$60,437.02, the January financials, and the January 10 minutes and the building permit for Sara Friedrichsen. Damstra support. Motion carried 4-0.

Council had a discussion whether the city should consider putting in place wards within the town. The council feels there could be challenges have wards in place for a town our size. We will continue to encourage people to run for council from all areas of town and will encourage growth and improvement within the entire city.

A discussion was had regarding replacing the city/library sign in front of the city/library building. We will continue with moving forward with picking out a sign to replace the current one.

Council discussed the option of putting up sun shades in the park near the splash pad. B. Koerselman made a motion that the city supports the project to be headed by the park revitalization committee. For them to come up with a plan to provide shelter/shades/trees and to work with the city to understand the project. Damstra support. Motion carried 4-0.

Council reviewed the proposed Fiscal Year 2023 budget that was prepared.

B. Koerselman made a motion to approve Resolution 2022-05 setting the time a place for a public hearing for the proposed fiscal year 2022-2023 budget. Jungers seconded the motion. Roll call vote: 4-0. Motion passed.

With no further business B. Koerselman made a motion to adjourn the meeting. Jungers supported. Motion carried 4-0. Meeting was adjourned at 7:15 p.m.
